REGULATIONS OF THE AGRO SHOW 2025 EXHIBITION

GENERAL PROVISIONS

- § 1. The Regulations define the rules applicable during the XXVI International Agricultural Exhibition AGRO SHOW 2025 (hereinafter referred to as the Regulations and the Exhibition, respectively).
- § 2. The purpose of the Exhibition is to present products, services, other means of agricultural supply or machines and equipment for agriculture (including during work).
- § 3. The organizer of the Exhibition is the Polish Chamber of Commerce for Agricultural Machines and Facilities with its registered office in Toruń (address: ul. Poznańska 118, 87-100 Toruń, KRS: 0000052908, for which the registration files are kept by the District Court in Toruń, 7th Commercial Division of the National Court Register, NIP: 8792094184, REGON: 87116655900000).
- § 4. The Regulations apply throughout the entire Exhibition (the entire airport in Bednary) and apply to all entities staying on the Exhibition premises, including its participants, i.e. Exhibitors, Sub-exhibitors, Visitors, Service Providers.
- § 5. The Exhibitor is an entity presenting products, services and other means of agricultural supply or machinery and equipment for agriculture, which has provided the Organizer with an Application for Participation in the Exhibition as an Exhibitor and whose participation as an Exhibitor has been confirmed by the Organizer.
- § 6. A Sub-Exhibitor is an entity that has not submitted an independent Application for Participation and participates in the Exhibition, with the consent of the Exhibitor and after being reported as a Sub-Exhibitor to the Organizer and accepted by the Organizer (in at least documentary form) presenting products, services, and other agricultural supplies or machinery and equipment within the Exhibitor's Stand and rights. When the Regulations refer to the obligations of the Exhibitor (if they are not obviously reserved for Exhibitors) they also refer to the Sub-exhibitors. The Exhibitor shall be liable for the acts and omissions of the Sub-Exhibitor as for its own acts.
- §6¹ A visitor is a natural person who has the right to enter the Exhibition, both as a consumer, i.e. visiting the Exhibition without any connection with his business or professional activity, and as a professional visitor, i.e. visiting the Exhibition in connection with his business or professional activity.
- § 7. Service providers are entities other than Exhibitors, Sub-Exhibitors and Visitors who stay on the Exhibition premises and provide services there, with the consent of the Organizer, to persons present on the Exhibition premises, e.g. entities providing catering, forwarding, transport services, etc. Service providers are obliged to have civil liability insurance within the scope of business activities performed during the Exhibition.

- § 8. The Exhibition for Visitors is open from 19 to 21 September 2025 from 9:00 a.m. to 5:00 p.m., unless the Organizer decides to change the opening hours of the Exhibition. Entry to the Exhibition is prohibited for persons:
- under the influence of alcohol or narcotics (similar substances).
- in possession of dangerous tools (including weapons).

Persons under the influence of alcohol or narcotics (similar substances) are prohibited on the premises of the Exhibition. The Organizer and Security have the right to conduct sobriety tests and tests for the presence of narcotics (or similar substances), if there are reasonable doubts in this respect, and anyone staying on the premises of the Exhibition or wishing to enter it is obliged to undergo such a test. The Organizer and Security may remove persons under the influence of alcohol, narcotics (other similar substances), or refusing to undergo testing from the premises of the Exhibition or may refuse them entry to the premises of the Exhibition.

- § 8¹ Children and adolescents up to 18 years of age may stay at the Exhibition only under the supervision of an adult entitled to provide such care (parents, legal guardian, duly authorised person).
- § 82 It is prohibited to conduct business activity on the Exhibition premises by any entities, in particular to provide services to persons present on the Exhibition premises, with the exception of Exhibitors, Sub-exhibitors, in the scope of activities related to the scope indicated in paragraph 2 of these Regulations, and Service Providers (to the extent of the consent granted by the Organizer and to the extent to which they fulfil their tasks within the Exhibition). In the event of violation of this prohibition, the Organizer has the right to remove from the Exhibition area an entity that does not comply with this provision and impose a fine of PLN 2,000 on it
- § 8³ The Stand is the area designated by the Organizer for the Exhibitor, where it is presented as part of the Exhibition, together with any construction and equipment.
- § 9. It is prohibited to bring animals or bicycles into the exhibition area, with the exception of assistance dogs.
- § 10. Within the Exhibition area, all payments to the Organizer may be made by payment card or up to PLN 200 in cash. In the case of other currencies, the price or exchange rate set by the Organizer applies.

SERVICES PROVIDED BY THE ORGANIZER

- § 11. In connection with the preparation of the Exhibition, the Organizer ensures:
- 1) organization and conduct of the Exhibition,

- 2) promotion of the Exhibition,
- 3) services included in the registration fee,
- 4) placing an entry concerning the Exhibitor in the exhibition catalogue published in electronic form,
- 5) marking out the exhibition area (Stands), communication routes and parking lots,
- 6) management of municipal waste, with particular exception of removal of Stand construction and its equipment, organization and conduct of the Exhibition,
- 7) access to electricity (0.1-2.5 kW socket).
- § 12. The Organizer provides to Exhibitors, as part of the paid registration fee:
 - 1) 20 admission tickets,
 - 2) Exhibition Catalogue in electronic version,
 - identifiers,
 - 4) a designated undeveloped Stand in an open area or an equipped Stand in a tent hall,
 - 5) a place to put advertising materials in the Press Office.
- § 12¹. For remuneration, the Organizer, at the request of the Exhibitor, may provide services in the field of:
 - advertisements in the Exhibition Catalogue in electronic version,
 - 2) unloading and loading of exhibition exhibits,
 - 3) ensuring access to electricity,
 - 4) individual Stand protection,
 - 5) advertising masts,
 - 6) additional equipment,
 - drinking water dispensers, water bottles and disposable cups,
 - reserving a space in a subscription (guarded) car park,
 - car park for cars with a permissible total weight exceeding 3.5 t (unguarded paid TIR car park),
 - 10) distribution of advertising materials within the Exhibition area and car parks,
 - 11) advertisements on access roads within the airport,
 - 12) placing the logo on exhibition plans,
 - 13) Stand cleaning services,
 - 14) Internet at the Stand,
 - 15) possibility of machines participating in field shows,
 - 16) possibility of presenting machines on the runway,
 - notification of earlier installation on the principles specified later in the Regulations and in separate Regulations applicable in this respect.
- § 13. The Stand rental cost includes marking out an undeveloped Stand or preparing a Stand in a tent hall and using (renting) this space, while within the registration fee the Organizer provides each Exhibitor and Sub-Exhibitor with the services listed in § 12. The one-time waste removal fee includes the management of municipal waste, with the specific exception of the removal of Stand construction and its equipment. The Organizer provides other additional

services to Exhibitors and Sub-Exhibitors for a separate fee, specified by the Organizer. The registration fee is paid for each Stand separately.

- § 14. The Organizer ensures on the Exhibition premises:
 - 1) protection provided by an external entity with appropriate authorizations (Security),
 - 2) medical assistance,
 - 3) sound system,
 - 4) operation of catering outlets, operation of catering points that sell and provide services for a separate fee,
 - 5) public Wi-Fi Internet,
 - 6) maintenance of cleanliness, excluding cleaning of Stands, in particular after the end of the Exhibition,
 - 7) possibility of using toilet cabins,
 - 8) conducting demonstrations and presentations of machines (participation in demonstrations and presentations takes place on the terms set out in separate regulations, in accordance with the principles specified therein).

CONDITIONS OF PARTICIPATION IN THE EXHIBITION BY EXHIBITORS AND SUB-EXHIBITORS

- § 15. An Exhibitor intending to participate in the Exhibition is obliged to provide the Organizer with a correctly completed Application Form, at least in documentary form, within the specified deadline for submitting applications. Applications submitted after this deadline will be accepted to the extent possible, provided that the Organizer may not provide all services despite the obligation to pay the entire amount of fees for participation in the Exhibition (in particular registration fees, Stand rental, additional services, etc.) and individually establish payment terms. At its own discretion, the Organizer may require the entity that submitted the application in documentary form to submit it in written form. Application Forms constitute an integral part of the agreement between the Organizer and the Exhibitor.
- \S 16. The order for undeveloped Stand space should include one of the modules specified by the Organizer, and for the space in the tent hall a module of 6 m2 (2 m x 3 m) or its multiple.
- § 17. The Exhibitor is obliged to notify the Organizer of Sub-exhibitors who will co-exhibit at his Stand and pay the registration fee for each of them. Sub-exhibitors are not allowed to exhibit without their registration and acceptance by the Organizer. In the event of a lack of registration of a Sub-exhibitor or lack of acceptance by the Organizer, the Organizer may demand that such an entity ceases to exhibit at the Exhibitor's Stand, and such an entity is not entitled to any benefits from the Organizer provided for Sub-exhibitors.
- § 18. An Exhibitor who is a member of the Organizer cannot have Sub-exhibitors who are not members of the Organizer and Sub-exhibitors who are members of the Organizer with a different type of membership (ordinary, extraordinary,

standard). In justified cases, the Organizer may consent to a derogation from this rule, provided that the Sub-Exhibitor pays the Sub-exhibitor at the rates that would apply to the Sub-Exhibitor if it independently reported its participation in the Exhibition as an Exhibitor.

- § 19. After receiving the Application (including the Application for Participation form), the Organizer confirms its acceptance by specifying the total cost of participation of the given Exhibitor (pro-forma invoice) in PLN or, in the case of countries outside the European Union, in Euro at the exchange rate set by the Organizer. For additional orders placed after the pro-forma invoice is issued, further supplementary pro-forma invoices are issued, if the Organizer accepts them for execution. Failure to provide the entity submitting the pro-forma invoice referred to above means that the application is not accepted.
- § 20. The amount and conditions for granting discounts for the rental of undeveloped Stands are specified in separate regulations.
- § 21. The cost of participation specified on the pro-forma invoice must be paid by the Exhibitor to the Organizer within the time specified on the pro-forma invoice, but no later than August 14, 2025. In the event of an application submitted after the deadline for submitting applications and accepted by the Organizer, the payment deadline is set by the Organizer.
- § 22. The Organizer has the right to refuse to confirm acceptance of the Exhibitor's Application and to refuse to consent to the Sub-Exhibitor's participation in the Exhibition without giving reasons.
- § 23. An Exhibitor who has registered for participation by 13 June may withdraw from participation in the Exhibition or from individual services ordered earlier no later than 27 June 2025 by submitting a written declaration to the Organizer under penalty of nullity. After 27 June 2025, withdrawal is not possible. In the event of withdrawal that does not meet the conditions indicated above, the Exhibitor is obliged to pay all fees even if they will not participate in the Exhibition (for any reason, unless these Regulations provide otherwise). An Exhibitor who has registered for participation in the Exhibition after the deadline for submitting applications does not have the right to withdraw.
- § 24. An Exhibitor who did not participate in the Exhibition but did not submit his/her resignation on time is obliged to cover the cost of participation specified in the pro-forma invoice.
- § 25. The Organizer may not allow participation in the Exhibition and may also remove from the Exhibition area the Exhibitor and their Sub-Exhibitors in the event of failure to pay all costs of participation in the Exhibition, as well as Exhibitors and Sub-Exhibitors who do not realize the purpose specified in § 2 of the Regulations through their participation. Despite not being allowed to participate in the Exhibition or being removed from its area, the Exhibitor is charged with the full costs of participation without the right to any claims against the Organizer. In the event of a breach of the Regulations

resulting in removal from the Exhibition, the Exhibitor is not entitled to a refund of any fees, and the Organizer may claim compensation on general terms.

§ 26. All orders placed with the Organizer for any services, including Additional Services, at the Exhibition premises (not covered by the original application) will be fulfilled only as far as possible, provided that the payment for them will be higher by 100% of the original amount set by the Organizer (i.e. it will be 200% of the price).

CONDITIONS OF PARTICIPATION OF OTHER ENTITIES

- § 27. The participation of other entities, including Service Providers, in the Exhibition is only permitted with the consent of the Organizer and on the terms and conditions established by the Organizer. Refusal to allow participation does not require justification.
- § 28. Entities located on the Exhibition premises without the Organizer's consent may be removed from the Exhibition without the right to any claims and be obliged to pay a contractual penalty of PLN 4,000 to the Organizer.

THE STAND

- § 29. The Stands are intended for exhibition of Exhibitors and Sub-exhibitors to the extent provided for in § 2 of the Regulations. The Stands do not have water and sewage installations (such installation is not connected to them).
- § 29¹. The Exhibitor is fully liable (on a risk basis) for all behaviour (actions and omissions) of persons present within the Stand and the functioning (movement, spontaneous action or caused by the action of any person) of devices located within the Stand, in particular involving violation of legal provisions, regulations, etc.
- § 29². The Exhibitor is obliged to develop the Stand, in particular in terms of the elements placed on it (tents, containers, etc.) in accordance with the provisions of law, the latest technical and construction knowledge, including health and safety and fire protection, taking into account the ground and weather conditions. The Exhibitor assumes full and exclusive liability towards all third parties, including the Organizer, for failure to comply with the principles indicated in sentence 1 of this paragraph. The Organizer may demand that the Exhibitor remove elements of the Stand or remove such elements at the expense and risk of the Exhibitor, if they pose a threat or do not meet the requirements resulting from sentence 1 of this paragraph.
- § 29³. The method of development, equipment, use and dismantling of the Stands may not pose a threat to persons or property and may not prevent or hinder:
- 1) the use of the Stands by other Exhibitors,
- 2) the use of internal roads designated by the Organizer,
- 3) the performance of duties by the Exhibition staff.
- § 29⁴. The construction of Stands, assembly of devices (exhibits), all installations and advertising media should be carried out and completed in such a way that they do not pose

- a threat to public safety and order, and in particular to the life and health of persons present at the Exhibition.
- § 29⁵. All visible rear walls of Stands should be finished in a neutral colour (white).
- § 30. The location of the Stands is determined by the Organizer on the Exhibition Plan. The Exhibition Plan will be posted on the website www.agroshow.pl and sent to Exhibitors by e-mail.
- § 31. Stand construction may take place from 12 to 14 September 2025, from 08:00 to 19:00, 15 to 17 September 2025, from 08:00 to 20:00 and on 18 September 2025 from 08:00 to 21:00. The development and restoration of the Stand area to its original condition (including dismantling of Stand elements) and removal are carried out by the Exhibitor on their own, at their own risk and expense.
- § 32. On 21 September 2025 (Sunday), the dismantling of the Stand may take place from 17:00 to 21:00, except that:
- 1) it is strictly forbidden to drive cars with a GVW above 3.5 tons on the airport premises,
- 2) self-propelled machines may leave the exhibition area from 20:00.
- § 33. Disassembly and removal of equipment on 22 September 2025 from 08:00 to 21:00, on 23 September 2025 from 08:00 to 19:00, on 24 September 2025 from 08:00 to 18:00 and on 25 September 2025 from 08:00 to 16:00.
- § 34. If using the services of a company that builds the Stand, delivers materials to the Stand, or an external catering company, or the services of another third party, the Exhibitor is obliged to provide the Organizer with its data in electronic form no later than 8 August 2025.
- § 35. Without the prior consent of the Organizer, granted at least in a documentary form, Exhibitors may not change or combine Stands, change the numbering of Stands or make any other modifications.
- § 36. It is forbidden to occupy space outside the designated Stand area, especially traffic routes, both in terms of their surface area and the air strip above it. In the event of violation of this prohibition, the Organizer has the right to remove, at the Exhibitor's expense, any elements protruding outside the Stand and to charge the Exhibitor with a contractual penalty of PLN 2,000, provided that in the case of vehicles the provisions of § 75 apply. In the event of the technical possibility of renting additional space, the Organizer collects a fee from the Exhibitor for the additional space the price increases by 100% in relation to the price indicated in the application forms. The Organizer has the right to demand the removal of the violation or to have it removed at the cost and risk of the Exhibitor.
- § 37. If property is left at the Stand including waste (this includes municipal waste that has not been placed in containers intended for its storage) after 4 p.m. on 25 September 2025, the Exhibitor will be obliged to pay the Organizer a contractual penalty in the amount of PLN 150 for

each commenced hour. The Organizer may also remove such items from the Exhibition area at the Exhibitor's expense. The Organizer bears no responsibility for any damage incurred by the Exhibitor.

ELECTRIC POWER SUPPLY

- § 38. Providing electricity includes supplying power to the Stand on 18-21 September 2025. Additionally, the Exhibitor may order:
- 1) early supply of power to the Stand on 15-17 September 2025.
- 2) power supply to the Stand during the Stand dismantling period on 22 September 2025,
- 3) providing connections to the places indicated at the Stand and renting electrical switchboards.
- § 39. On the exhibition grounds, both the Organizer and the Exhibitors are subject to Polish regulations for the construction/installation and operation of electrical power equipment, as well as applicable Polish standards and occupational health and safety regulations.
- § 40. Electrical connections are led to the centre of the rear wall of the Stand and terminated with sockets in accordance with the order submitted in the Application for Participation. The connection will be equipped with devices that cut off the power supply if the ordered power is exceeded.
- § 41. The distribution of power on the Stand surface is the responsibility of the Exhibitor, unless he has ordered this service from the Organizer. When ordering a connection to the places indicated at the Stand, the Exhibitor is obliged to provide the Organizer with the order with a plan showing the places to which the electrical installation is to be connected. The installation will not be located within the Exhibition area.
- § 42. Electrical installations above 2.5 kW at the Stand must have a main switch and 30mA residual current protection. Equalizing connections and devices should be used to ensure quick disconnection of the power supply if the safe touch voltage value is exceeded.
- § 43. Electricity will be supplied to the Stands from 15 22 September 2025, during the hours specified in § 45.
- § 44. The Stand's power supply will be connected after the Exhibitor submits a request to the Exhibition Office. The order of applications will determine the time of connection of the Stands.
- § 45. The Stands will be powered by electricity in accordance with the order:
- 1) 08:00 20:00 from 15 to 17 September 2025,
- 2) 08:00 21:00 on 18 September 2025,
- 3) 08:00 19:00 from 19 to 20 September 2025,
- and 08:00 17:00 on 21 September 2025,
- 4) 08:00 21:00 on 22 September 2025.

- § 46. For safety reasons, outside the hours specified in § 45, the electricity supply to the Stands will be disconnected, unless, at the Exhibitor's justified request, the Organizer agrees to a longer power supply to the Stand on days from 15 to 18 September or on 22 September 2025.
- § 47. From 8 August 2025 and during the Exhibition, any additional orders or changes in relation to previous orders will be implemented only if technically possible and after paying the appropriate fee. The Organizer decides about the provision of additional services referred to in sentence 1 and the amount of remuneration.
- § 48. The organizer is not responsible for interruptions in electricity supply.
- § 49. The Organizer will not accept any complaints related to power outages caused by exceeding the ordered power.
- § 50. The ordered electrical switchboards will be available to Exhibitors from 15 21 September 2025.

PRESENTATION OF MACHINES ON THE RUNWAY

- § 51. Only Exhibitors who have ordered an exhibition Stand may submit machines for presentation.
- § 52. Machines approved by the Organizer are subject to presentation.
- § 53. The place and course of the presentation are determined by the Organizer.
- § 54. The price for the presentation includes marking out and fencing the presentation site.

WORKING MACHINERY DEMONSTRATIONS

- § 55. Only Exhibitors who have declared their intention to participate in the shows in the Application for Participation are allowed by the Organizer to participate in the shows. The organizer may refuse to accept the application without justifying the decision.
- § 56. The conditions and rules for participation and conducting demonstrations are specified in the Regulations for machine demonstrations and the application form.

ADVERTISING FLAG POLES

- § 57. The rental of advertising masts also includes their assembly and disassembly. The Organizer has the right to refuse to perform the service of assembling masts due to weather conditions (in particular, due to improper ground conditions, strong wind, precipitation, etc.), other external circumstances that may lead to the creation or increase of a threat to the participants of the Exhibition. The Organizer is not responsible for the failure to perform the services in the scope indicated in the preceding sentence.
- § 58. The Exhibitor is obliged to send the Organizer a design of the arrangement of the ordered advertising poles at the

- Exhibitor's Stand by 1 August 2025. In the absence of such a design, the Organizer may, at its own discretion, refrain from installing the masts or install them in places within the area designated for the Stand, at the Organizer's discretion.
- § 59. The poles cannot be located closer than 60 cm from the side border of the Stand and 15 cm from the border of the front of the Stand.
- § 60. The poles are made of fiberglass and are 8 m high. The maximum size of the flag that can be placed on the mast is: 1.5 m x 4 m (width x length). The flag must be made only of polyester 110-130g. In particular, it is forbidden to hang any elements on or near the mast, other than a flag with the parameters indicated in this paragraph, in particular banners made of PVC or other materials. The masts are not equipped with a horizontal flag boom as standard.
- § 61. In the event of damage to the pole, the Exhibitor will be obliged to pay the Organizer the costs of its repair, and in the event of destruction or loss of the pole a contractual penalty of PLN 1,000 for each pole.
- § 61¹. The Organizer may refrain from providing the service or order the flags to be removed from the masts or dismantled if for any reason they constitute a threat to safety, in particular due to unfavourable weather conditions.

OTHER ADDITIONAL SERVICES

- § 62. The conditions for placing a mandatory entry and advertising in the Electronic Exhibition Catalogue are specified in the application forms. Including additional information in the mandatory entry in the Electronic Exhibition Catalogue, beyond that specified in the application form, requires arrangements with the Organizer and an additional fee. The organizer is not responsible for errors and omissions in the catalogue.
- § 63. Individual Stand security is carried out in accordance with the principles specified in the procedures established by the Organizer.
- § 64. Distribution of advertising materials and all other materials in the Exhibition area outside the Exhibitor's Stand, as well as in the car parks, will only be carried out by persons allowed to do so by the Organizer and equipped with IDs issued by the Organizer. Distribution on access roads and in places that obstruct vehicle traffic is prohibited.
- § 65. Advertising on access roads within the airport will consist in placing advertising banners provided by the Exhibitor.
- § 66. An Exhibitor who does not return the ordered additional equipment is obliged to pay its equivalent determined by the Organizer.
- § 67. The organizer is not responsible for interruptions or difficulties in access to the Internet caused by technical reasons.
- § 68. The conditions for using the subscription (guarded) car park are specified in separate regulations. Exhibitors and

sub-exhibitors may order a parking card for the duration of the car park's operation along with registering for participation in the Exhibition. Orders for shorter periods can only be placed on the Exhibition premises directly with the parking staff.

§ 69. Cars with a permissible total weight exceeding 3.5 t (except for buses) may park at the Exhibition area only in the place designated by the Organizer (unguarded paid TIR car park). If no prior parking order is made using the appropriate form, the entry fee is PLN 400 gross.

VEHICLE MOVEMENT AND PARKING

- § 70. Throughout the Exhibition and access roads, general road traffic rules applicable on public roads, as in the residential zone, apply. The speed limit throughout the entire Exhibition area is 20 km/h.
- § 71. The movement of motor vehicles is allowed within the Exhibition area along designated communication routes:
- 1) from 12 to 18 September 2025,
- 2) on 21 September 2025 after 17:30,
- 3) from 22 to 25 September 2025.

Particular caution is required.

- § 72. Subject to § 73, on 19-20 September 2025 and on 21 September 2025 until 17:30, there is an absolute ban on the movement of motor vehicles on the Exhibition premises, with the exception of emergency vehicles (ambulances, law enforcement vehicles, fire brigade vehicles, security vehicles, service providers permitted by the Organizer, etc.) and marked vehicles of the Organizer and vehicles equipped with a Service Card issued by the Organizer.
- § 73. An exception to the rule specified in § 72 is the possibility of entry of the Exhibitor's vehicle to the Exhibition area on 19-20 September 2025 from 17:30 to 18:30 and leaving the Exhibition area by 19:00. The condition for entry is to pay a cash deposit of PLN 200. The deposit will be forfeited, constituting a contractual penalty for the Organizers, if the vehicle does not leave the exhibition grounds by the time indicated above.
- § 74. Parking at the Exhibition area is allowed only in parking areas designated by the Organizer.
- § 75. Vehicles parked on the Exhibition premises when it is open to Visitors, vehicles that have not left the Exhibition premises in accordance with the provisions of § 73, vehicles parked in prohibited places, in particular in the bus parking lot, will be removed to the parking areas or clamped. The entity whose vehicle is removed will be obliged to pay the Organizer flat-rate related costs (tow truck) in the amount of PLN 1,000 gross. Additionally, regardless of whether the vehicle is removed and regardless of the forfeiture of the deposit, the Exhibition participant will be obliged to pay the Organizer a contractual penalty in the amount of PLN 1,000. There is a contractual penalty of PLN 1,000 for removing the wheel clamp.

- § 76. The Organizer may equip the Exhibitor's service vehicle with a Service Card only in exceptional cases, if required by the technical service of the Exhibitor's machines participating in the shows. Vehicles equipped with a Service Card should be parked in a specially marked parking lot until 08:45 and may only move between their designated parking lot and the show field.
- § 77. The movement of machines intended for demonstrations may only take place during the hours and under the conditions specified by the Organizer.
- § 78. The Organizer and Security may carry out sobriety or psychoactive substances checks of persons driving any vehicles throughout the Exhibition and take any action in case of finding intoxication or presence of psychoactive substances, in particular removal of such person from the Exhibition area.
- § 79. The Organizer and Security are authorized to take all actions aimed at ensuring compliance with the provisions of the Regulations, in particular those contained in §§ from § 70 to § 78 of the Regulations.
- § 80. No entities, in particular Exhibitors, Sub-Exhibitors, Service Providers and Visitors, shall be entitled to any claims, including claims for damages, for any consequences of actions taken by the Organizer or Security to ensure compliance with the provisions of the Regulations, in particular the provisions contained in §§ from § 70 to § 78 of the Regulations.

STAYING ON THE EXHIBITION AREA

§ 81. Outside the hours:

1) 08:00 - 19:00 on 12-14 September 2025,

2) 08:00 - 20:00 on 15-17September 2025,

3) 08:00 - 21:00 on 18 September 2025,

4) 07:00 - 19:00 on 19-20 September 2025,

5) 07:00 - 21:00 on 21 September 2025,

6) 08:00 - 21:00 on 22 September 2025,

7) 08:00 - 19:00 on 23 September 2025,

8) 08:00 - 18:00 on 24 September 2025,

9) 08:00 - 16:00 on 25 September 2025.

- it is forbidden for any persons to stay on the Exhibition premises, apart from Security and persons acting on behalf of the Organizer.
- § 82. Any stay on the premises outside the hours specified in § 81 requires prior consent from the Organizer and persons authorized by the Organizer.
- § 83. Security has the right to forcibly remove from the Exhibition premises persons who significantly violate the provisions of the Regulations, in particular the prohibition referred to in § 81, if the consent referred to in § 82 has not been granted and the arrangements have not been made. Security is authorized to perform all activities indicated in the

provisions of the Act of 22 August 1997 on the protection of persons and property (consolidated text: Journal of Laws of 2021, item 1995)

SECURITY

- § 84. The purpose of the activities undertaken by Security is to ensure safety and order (correct behaviour of people staying on the Exhibition area) on the Exhibition area and to protect the Exhibition area. The activities indicated in sentence 1 are performed only by uniformed Security staff.
- § 85. Security staff may issue orders to any entities staying at the Exhibition area to ensure safety and order. All entities staying on the Exhibition premises are obliged to comply with such instructions.
- § 86. Before leaving the Stand, Exhibitors are required to properly secure the entire Stand and all movable property located there (including, among others, their exhibits and equipment), in particular their display and equipment. Individual Stand security will be provided only if ordered in the Application for Participation.
- § 87. Equipment may be removed from the Exhibition area only on the basis of a Material Pass issued by the Organizer at the Exhibition Office. The Organizer has the right to waive the obligation to present material passes. The Organizer is not responsible for the removal of any elements (equipment, exhibits, etc.) from the Exhibition area.
- § 88. Vehicles leaving the Exhibition area are subject to inspection, the purpose of which is to check the vehicle for equipment exported from the Exhibition area. As part of the inspection, Security may record the driver's personal data and vehicle data and demand the production of the Material Pass referred to in § 87. In case of refusal to submit to inspection or to provide the above mentioned data, Security or the Organizer have the right to stop the vehicle and the persons inside it until the arrival of the relevant services.

UNLOADING AND LOADING

- § 89. Unloading and loading equipment is made available primarily to Exhibitors who reported the need in the Application for Participation.
- § 90. The conditions and rules for unloading and loading are specified in separate Unloading and Loading Regulations and the application form.

ORDER PROVISIONS

- § 91. From 12 to 23 September 2025 the Exhibition Office will be open from 08:00 to 18:00.
- § 92. Without the consent of the Organizer, it is not allowed to dismantle the Stand or remove the equipment and exhibition elements during the Exhibition.
- § 93. With the exception of advertisements placed at the Stand and advertisements ordered and permitted by the Organizer outside the Stand, any other forms of advertising within the Exhibition area require the prior consent of the

- Organizer. In the absence of such consent, advertisements will be removed at the expense and risk of the advertiser.
- § 94. Without the prior written consent of the Organizer, any political activity on the Exhibition premises is prohibited.
- § 95. All persons present on the Exhibition grounds, in particular Exhibitors, Sub-exhibitors, Service Providers, Visitors are obliged to comply with the Regulations, other regulations and to comply with all orders and decisions of the Organizer and persons employed by the Organizer to operate the Exhibition, as well as Security (within the scope of its competence). In cases of dispute, including those regarding the interpretation of the regulations, the final decisions are made by the Exhibition Director, appointed by the Organizer.
- § 96. Exhibitors, Sub-exhibitors and Service Providers are obliged to ensure compliance with the regulations applicable at the Exhibition area by their staff and entities acting on their behalf (regardless of the legal form of cooperation) and bear full responsibility for such entities, on a risk basis, as for their own actions.
- § 97. Exhibitors bear the responsibility referred to in § 96 also for Sub-exhibitors co-exhibiting at their Stands.
- § 98. In the event of an epidemic or outbreak of disease, as well as the introduction of any restrictions in generally applicable laws, for any reason whatsoever, all persons present on the Exhibition grounds must comply with the sanitary and epidemiological regulations currently in force, as well as decisions and orders, including those of the Organizer. Persons who do not comply with the requirements may be removed from the Exhibition area by the Organizer.
- § 99. Outside the opening hours of the Exhibition, organizing meetings and banquets at the Stands is prohibited. It is prohibited to undertake any activities that will disrupt the course of the Exhibition or the use of the Stands of other Exhibitors or the operation of Service Providers, through emission from the Stand area, in particular excessive noise. The Organizer may (at its own discretion) allow the organization of a meeting or banquet, which is subject to the prohibition specified in sentence 1 of this paragraph. In the event that the Organizer agrees to organize a banquet or meeting at the Stand, the Exhibitor bears full responsibility. The maximum sound pressure generated from the Stand may be 73 dB.
- § 100. The Organizer has the right to control compliance with the principles established in the Regulations, other Regulations, legal regulations, and decisions issued by the Exhibition Director within the scope of his competences. and to take action, including the use of direct coercion, in order to restore the condition in accordance with the Regulations and legal regulations.
- § 101. The Organizer reserves the right to record the course of the Exhibition with the participation of participants in any form. By entering and staying in the Exhibition area, all

entities present in the Exhibition area agree to the abovementioned registration.

§ 102. In the event of creating a threat to persons or property, disturbing order, violating the regulations and failing to comply with the orders and decisions of the Organizer and persons employed by the Organizer to operate the Exhibition, any entities staying in the Exhibition area may be removed from the Exhibition area, without the right to any claims, in particular for damages (to any extent), against the Organizer. In the event of a breach of the Regulations resulting in removal from the Exhibition, the Exhibitor shall not be entitled to a refund of any fees, and the Organiser may seek compensation on general terms.

§ 102¹. All provisions indicated and contained in the content of the application forms are binding and form part of the agreement between the parties, for entities submitting these forms - Exhibitors, as well as for entities exercising their rights within the Exhibition - Sub-Exhibitors.

LIABILITY AND COMPLAINTS

§ 103. The Exhibitor is not entitled to any claims, in particular for reimbursement of fees paid, or for compensation (in any scope) in the event of:

- 1) incomplete use of the Stand,
- 2) participation in only part of the Exhibition,
- resignation from some of the benefits provided by the Organizer.
- 4) failure to participate in the Exhibition, in whole or in part.
- § 104. The Organizer is not responsible for any property of the Exhibition participants damaged or lost, in particular as a result of theft or loss, as well as for damage caused by any entities present at the Exhibition premises (including those resulting from infringements of copyright and related rights).
- § 105. Exhibitors, Sub-exhibitors, service providers and other entities participating in the Exhibition should independently insure their property, in particular the exhibited and presented equipment, and have civil liability insurance. Exhibitors are required to have civil liability insurance, to the extent covering participation in the Exhibition, in an appropriate amount. The Organizer may request proof of conclusion of the insurance contract referred to in the preceding sentence. In the event of failure to provide proof of conclusion of the aforementioned insurance contract, the Organizer may remove the Exhibitor from the exhibition area or remove the Exhibitor from the exhibition area at the cost and risk of the Exhibitor.
- § 105¹. All Exhibition Participants, in particular: Exhibitors, Sub-Exhibitors, Service Providers, Visitors are fully and exclusively liable for their actions and omissions at the Exhibition, towards third parties, including the Organizer.

Participants are also liable on the basis indicated above for the actions and omissions of persons acting on their behalf, on any basis, as for their own actions.

- § 106. The Organizer is liable for failure to provide services related to the Exhibition if it was the result of his wilful misconduct.
- § 107. The Organizer shall not be liable for any consequences of force majeure, including, but not limited to, war, terrorist attack, act of vandalism, pandemic, technical failures beyond the control of the Organizer, or decisions of administrative authorities, as well as for the consequences resulting from unfavorable weather conditions, including the obligation to return benefits paid by the Exhibition participants in the event of cancellation, change of date, shortening, etc. of the Exhibition for these reasons.
- § 108. Exhibitors are obliged to report any complaints or reservations to the Organizer during the Exhibition in writing under penalty of nullity or by entering them in the complaint book located in the Exhibition Office.
- § 109. The Organizer reserves the right to cancel, shorten, change the date and place of the Exhibition, as well as limit its scope or introduce other restrictions, as well as derogate from the regulations without the right to compensation.
- § 110. In the event of the cancellation of the Exhibition, in particular due to the Covid-19 epidemic, the Organizer will be obliged to refund the Exhibitors the amounts paid by them to the extent to which it did not incur non-refundable costs of preparing the Exhibition. The Organizer is not liable for other payments made by Exhibitors to third parties or for lost profits.
- § 111. Disputes between Exhibition participants and the Organizer will be resolved by the courts competent for the Organizer's registered office. The applicable law is Polish law.
- § 112. Entering the Exhibition area and participating in it constitutes acceptance of the provisions of the Regulations and also expressing consent to the registration of the image and its publication in materials related to the Exhibition, its promotion virtual tour, promotional materials, etc., documenting its course, maintaining order, etc. (in particular: photos, recordings, including on social media and on the Exhibition website), when it is part of a larger whole (landscape). The consent of minor participants is expressed in the manner indicated in sentence 1, by the participation of their adult guardians in the Exhibition. The Organizer, as the administrator of the registered data, will be able to transfer it to third parties only for the purpose of obtaining it, and will be able to store this data for the period necessary to achieve the purpose of obtaining it.
- § 113. In case of doubts regarding interpretation, the text of the regulations in Polish shall prevail.

REGULATIONS FOR GRANTING DISCOUNTS FOR RENTING EXHIBITION SPACE

I. Ordinary members of the Polish Chamber of Commerce for Agricultural Machines and Facilities based in Toruń:

- 1) Are entitled to a basic discount of 50% of the price.
- **2)** An additional discount may be granted depending on the membership duration in the amount of:
 - **a)** 2% of the price for one year of regular membership (total discount 52%),
 - **b)** 5% of the price for two years of regular membership (55% discount in total),
 - **c)** 9% of the price for three years of regular membership (59% discount in total),
 - **d)** 14% of the price for four years of regular membership (total discount 64%),
 - **e)** 20% of the price for five years of regular membership (total discount of 70%),
 - f) 30% of the price for at least six years of regular membership (total 80% discount).
- **3)** In the event of a change in the nature of membership, each 3 full calendar years of extraordinary membership are treated as a year of ordinary membership.

II. Extraordinary members of the Polish Chamber of Commerce for Agricultural Machines and Facilities based in Toruń:

- 1) Are entitled to a basic discount of 30% of the price.
- **2)** An additional discount may be granted depending on the membership duration in the amount of:
 - **a)** 4% of the price for one year of membership (total discount of 34%),
 - **b)** 8% of the price for two years of membership (total discount of 38%).
 - **c)** 12% of the price for three years of membership (total discount 42%),
 - **d)** 16% of the price for four years of membership (total discount of 46%),
 - **e)** 20% of the price for at least five years of membership (50% discount in total).

III. Entities that are not members of the Polish Chamber of Commerce for Agricultural Machines and Facilities based in Toruń.

Are entitled to a discount of 15% of the price if the conditions specified in point IV of these regulations are met.

IV. Conditions for granting discounts:

- 1) Application for participation by 9 May 2025,
- 2) Payment for participation in the Exhibition within the deadline specified by the Organizer on the proforma invoice (failure to pay the amount due within the deadline specified in the pro-forma invoice results in the loss of the right to the discount).
- V. Conditions for granting an additional discount to members of the Polish Chamber of Commerce for Agricultural Machines and Facilities based in Toruń (hereinafter referred to as the Chamber)
 - 1) Additional discount is granted only in the case of:
 - a) being entitled to a basic discount,
 - **b)** timely settlement of all obligations towards the Chamber.
 - **2)** Late payments, within the meaning of point V.1) b), are considered:
 - **a)** being in default on payments to the Chamber of an amount of at least PLN 500 for a period of at least 7 days for any reason,
 - **b)** the Chamber's receivables, regardless of their amount, for which the Chamber requested legal proceedings.
 - 3) When determining the timely settlement of liabilities towards the Chamber, the period from the last day of the previous Exhibition to the first day of the Exhibition to which the discount applies is taken into account.
 - **4)** Membership duration is calculated in full calendar years until the first day of the Exhibition to which the discount applies, provided that members who submitted their declaration of joining the Chamber between the Exhibition and December 31 are entitled to one year as if they had submitted the declaration before the commencement of the Exhibition.

REGULATIONS FOR UNLOADING AND LOADING DURING THE AGRO SHOW EXHIBITION 2025

GENERAL PROVISIONS

- 1. The organizer, i.e. the Polish Chamber of Commerce for Agricultural Machines and Facilities based in Toruń, provides unloading and loading equipment in the form of cranes with a lifting capacity of up to 20 tons and telescopic loaders with a lifting capacity of up to 3 tons, as well as a loading ramp (forwarding activities). Performing services with the above-mentioned equipment is available for a fee. Equipment other than that of the Organizer (an entity authorized by the Organizer) cannot provide paid services referred to in sentence 1 and will be removed from the Exhibition area at the expense of entities that use these services (with the exceptions indicated in these regulations).
- **2.** Loading and unloading services will be provided in the first place to Exhibitors who ordered them when registering for participation in the Exhibition.
- **3.** In the case of ordering unloading and loading services after August 8, 2025, including on the Exhibition premises, the remuneration for their performance is the net price indicated in the original price list (in force at the time of registering for participation in the Exhibition) increased by 25% of the net price amount, i.e. the gross price amount will be 125% of the net price indicated in the original price list, rounded up to the nearest whole zloty.
- **4.** In the event of a change in the type of rented equipment (forwarding service) or the date of forwarding services, the Exhibitor is obliged to pay, in addition to the price of the services, in accordance with point 3 of these regulations, the following amounts:
 - the difference in the cost of renting equipment (forwarding services) originally ordered and resulting from the amended order (if the equipment (forwarding service) ordered in the amended order has a lower price, the difference in their value is not refundable to the Exhibitor), and
 - an additional fee of 25% of the price of the changed services, calculated in accordance with the principles set out in point 3.

Price and fee amounts are rounded up to the nearest whole zloty.

- 4 ¹. The current price list of forwarding services is available in the application forms available on the Organizer's website (www.agroshow.pl) and at the Forwarding Office.
- **5.** During unloading and loading activities, the Organizer is represented by the Forwarding Manager appointed by the Organizer, who supervises and manages the Forwarding.
- **6.** Subject to the provisions of points 7, 8 and 9, unloading and loading activities will be performed:
 - a) on 15 September 2025 from 8:00 to 16:00,
 - b) on 16 September 2025 from 8:00 to 18:00,
 - c) on 17 September 2025 from 8:00 to 20:00,
 - d) on 18 September 2025 from 8:00 to 21:00,
 - e) on 22 September 2025 from 8:00 to 21:00,

- f) on 23 September 2025 from 8:00 to 19:00,
- g) on 24 September 2025 from 8:00 to 18:00,
- h) on 25 September 2025 from 8:00 to 16:00.

The organizer has the right to stop unloading and loading activities at any time, in particular in the event of unfavourable weather conditions. When work is resumed, the order established before the work was interrupted will be maintained.

- **7.** Notifications for unloading and loading activities will be accepted only during the working hours of the Forwarding Office. After the working hours of the Forwarding Office, only works that have already been started will be completed.
- 8. Subject to point 9 commencement of unloading and loading works outside the hours specified in point 6 is possible only in exceptional situations after obtaining the prior explicit (not implicit) consent of the Forwarding Manager, who records this fact in the Confirmation of Forwarding Services. To obtain consent, it is required to present technical data of the exhibits, knowledge of their attachment points and mass distribution (including appropriate slings or other auxiliary elements, if required), as well as a visit to the Stand by a person authorized to operate equipment intended to perform forwarding activities (hereinafter: Operator). Unloading and loading works started after dusk and outside the hours specified in point. 6 take place at the sole risk and responsibility of the Exhibitor and in the event of any damage or any event causing any damage, the Exhibitor is not entitled to any claims against any third parties, in particular against the Organizer, Operator, Forwarding Manager. The Exhibitor assumes full responsibility for the performance of the abovementioned activities and for the persons it uses to perform them.
- **9.** Loading and unloading works using the ramp may only take place during the hours specified in point. 6 without the possibility of derogating from this rule.
- **10.** Loading and unloading operations will be performed based on the order of notifications received by the Forwarding Office on a given day. It is not possible to reserve equipment for the next day or any other day.
- **11.** The order of unloading and loading activities (execution of orders) is determined by the Forwarding Manager. The dates and times included in the notifications are only intended to provide guidance on the Exhibitors' needs for a given day and are not the basis for booking equipment or other claims. The Organizer is not bound by any indications regarding the dates and times of services, and Exhibitors are not entitled to any claims against the Organizer in this respect.
- **12.** Each time after the completion of a single forwarding operation (unloading, loading, etc.), the equipment must be placed at the exclusive disposal and possession of the Forwarding Office, and it is not possible to retain it in order to continue forwarding operations at a later time.
- **13.** If the downtime between operations exceeds 15 minutes, but the Exhibitor still wants to keep the equipment at its own disposal, this is possible only after obtaining the prior express

consent of the Forwarding Manager and verifying the time remaining to be used by the Exhibitor for forwarding services.

- **14.** The rules specified in point 13 also apply when the provided equipment, during activities related to the assembly of the exhibit, waits more than 15 minutes for the delivery of subsequent parts for assembly (e.g. located on another car that is still on its way to the Exhibition site).
- **15.** Any arrangements between Exhibitors and Operators do not bind the Organizer and will not be taken into account by the Forwarding Manager when determining the order of execution of orders.
- **16.** Each unusual order (e.g. the need to use two cranes working simultaneously, a crane with a lifting capacity exceeding 20 t or a forklift with a lifting capacity exceeding 3 t, etc.) requires, in addition to being specified in the order, confirmation of acceptance of the order for execution by the Exhibition Office no later than on 2 August 2024 and establishing separate payment terms.
- 17. An Exhibitor who wants to use a loader or crane other than that provided by the Organizer is obliged to report it to the Organizer on form D in order to obtain an Entry Permit. It authorizes you to enter the exhibition area and provide services only at the Exhibitor's Stand.
- **18**. If work is performed at a Stand other than that reported in the Entry Permit, a fine of PLN 1,000 will be charged for each activity performed. Responsibility for payment of the above contractual penalty will be borne by the Exhibitor who obtained the Entry Permit and the entity providing the service.

SAFETY RULES

- **19**. Only persons whose presence is necessary and who have appropriate qualifications to perform such activities and, if required, appropriate (current) authorizations may stay at the place where unloading and loading work is performed.
- **20**. During unloading and loading, all entities participating in these activities, in particular representatives, Exhibitors and the operators of means of transport, are obliged to strictly comply with health and safety rules and follow all instructions of the Forwarding Manager.
- **21**. Unloading and loading takes place at the sole risk and responsibility of the Exhibitor.

CRANE

- 22. The crane's operating time is counted from the moment the crane arrives at the Exhibitor. While the crane is operating, the crane performs activities preparing to pick up the exhibit (including unfolding the supports, positioning the arm, installing slings, etc.), activities related to unloading, loading, moving or setting up the exhibit and finishes with folding its supports, thus ending its work for the Exhibitor.
- 23. After completing all operations, the crane Work Card is signed, on which the time resulting from the performed operations is confirmed by the person representing the Exhibitor while performing forwarding activities with the crane.
- **24.** The crane operator cannot attach slings to the exhibit, all activities related to hooking the exhibit to the slings are performed by persons indicated by the Exhibitor as people who know the technological attachment points and the

location of the exhibit's centre of gravity. The crane operator may (but is not obliged) to assist in the above-described activities or perform them himself only at the express request of the Exhibitor and at his full risk and responsibility.

TELESCOPIC LOADER / FORKLIFT

- **25.** The operating time of the telescopic loader / forklift is counted from the moment of arrival of this equipment to the Exhibitor. During this time, preparation for unloading, loading or moving the exhibit takes place (including the visual inspection of the exhibit to determine places technologically adapted to the introduction of the loader/forklift forks), and the actual operation.
- **26**. After completing all operations, the Work Card is signed, on which the time resulting from the above-described operations is confirmed by the person representing the Exhibitor during the performance of forwarding activities.

RAMP

- **27.** The ramp is used only for unloading and loading work. Using the ramp for any other purposes, e.g. for assembly work, is prohibited.
- **28.** It is prohibited to unjustifiably occupy or block the ramp and the area around it, in particular by parking motor vehicles and machines, waiting for the arrival of subsequent cars with equipment for the Exhibitor, etc.
- **29.** Any devices blocking the ramp and the area around it will be removed at the Exhibitor's expense.

COMMENTS AND COMPLAINTS

- **30.** In all matters, especially in disputes, you should immediately contact the Forwarding Manager for clarification.
- **31.** In the event of damage occurring during the provision of forwarding services, the Exhibitor is obliged to immediately report this fact to the Forwarding Manager and the Organizer. Complaints filed after leaving the place of service provision will not be considered
- **32.** After signing the Work Card, no complaints or comments will be taken into account.
- **33.** Complaints and comments related to the order in which forwarding work is performed, the waiting time for the execution of a previously placed order and the inability to reserve equipment or leave equipment for more than one forwarding operation with one Exhibitor will not be taken into account.
- **34.** The Organizer may refuse to perform a forwarding service in the event that its performance may, for any reason, endanger the life or health of people or animals. In particular, such refusal may result from reasons related to the occurrence of force majeure, bad weather conditions, other significant circumstances that prevent or hinder their performance. In the event of refusal to perform the service in accordance with sentence 1 of this point, the Exhibitor (Sub-Exhibitor) shall not be entitled to any claims against the Organizer (entities acting on its behalf), in particular claims for damages.
- **35.** In the event of non-use of the ordered loading and unloading services, no refund will be made.

REGULATIONS FOR DEMONSTRATIONS DURING THE AGRO SHOW 2025 EXHIBITION

- 1. These regulations specify the organizational rules for demonstrations of machines at work during the AGRO SHOW 2025 Exhibition, organized by the Polish Chamber of Commerce for Agricultural Machines and Facilities based in Toruń ("Organizer").
- **2.** Presentation of equipment operation is allowed only outside the Exhibitor's Stand and only at the place designated by the Organizer.
- **3.** The number of machines taking part in the shows is limited. The Organizer decides whether the machine will be admitted to the show.
- **4.** The Organizer allows only Exhibitors who meet all the conditions provided for in the Exhibition Regulations and these Show Regulations to take part in the shows.
- 5. The shows take place on September 19-21, 2025.
- **6.** The person responsible for managing the shows ("Show Manager") is appointed by the Organizer.
- 7. Each Exhibitor is obliged to appoint its own trained staff in a number sufficient to operate the machines presented by it for all activities related to the preparation, conduct and conclusion of the shows and to provide the Organizer with a short description of the machine. The Exhibitor's staff is obliged to follow the rules for conducting demonstrations, safety rules, as well as all manufacturer's instructions provided for the presented machines, as well as all instructions of the Show Manager.
- **8.** Each Exhibitor may be obliged by the Organizer to delegate (in addition to the staff listed in point 7) one competent employee to assist the Show Manager.
- **8**¹·The exhibitor is obliged to have valid civil liability insurance covering risks related to participation in machine demonstrations.
- **9.** The Show is managed by the Show Manager, who issues binding orders to participants and persons designated to assist him by the Organizer.
- **10.** The preliminary conditions for qualifying a machine to participate in the shows are:
 - timely payment of the participation fee and
 - providing a description of the machine
- **11.** The Show Manager prepares a schedule of shows specifying:
 - a) participants the Exhibitor and the presented machine.
 - b) place of shows,
 - c) quantity and type of equipment presented by each Exhibitor,
 - d) the order of operation of machines,
 - e) approximate duration of individual presentations.

- **12.** The show schedule will be presented to show participants during the organizational meeting on 18 September 2025 at 12.00.
- **13.** In organizationally justified cases, the schedule may be changed in whole or in part by the decision of the Show Manager.
- **13**¹. Additional shows not included in the schedule may only be performed after obtaining the consent of the Show Manager.
- **14.** In the event of a change in the order of shows, the Show Manager informs the participants in advance, allowing them to prepare for the show.
- **15.** Exhibitors taking part in the show are obliged to leave the machines in a special parking lot until 18:00 on 18 September 2025 and each time after participating in a machine show.
- **16.** The organizer does not provide participants with any additional equipment, materials, etc. necessary to participate in the show.
- **17.** Every day at 10.00 The Show Manager may organize a briefing with persons designated by Exhibitors to determine the order and rules for conducting the equipment presentation, in particular with regard to safety conditions.
- **18.** An exhibitor who does not show up at the briefing on 18 September and on the days of the presentation and does not confirm his/her participation will be excluded from the shows on that day. In such a case, the participant will not be entitled to any claims, including damages, against the Organizer, in particular a claim for a refund of the fee paid.
- **19.** Machines intended for demonstrations wait for presentation at the place designated by the Organizer.
- **20.** The presentation participant is obliged to prevent the equipment from starting while parked.
- **21.** After the show, the equipment may be moved to the parking lot of demonstration machines only with the prior, express consent of the Show Manager with particular caution.
- **22.** On the day of the presentation, half an hour before the start of the show, the machines are grouped in the place and formation indicated by the Show Manager to ensure full readiness for the show.
- **23.** During the show, the operator of the machine or device starts it only upon the express command of the Show Manager.
- **24.** Show participants and staff, employees and associates of the Exhibitor are obliged to immediately and fully comply with all instructions of the Show Manager.
- **25.** If a show participant violates any of the provisions of these Regulations, as well as the instructions referred to in point 24 of these regulations, the Show Manager has the

right to exclude the Exhibitor from the shows. In such a case, the Exhibitor will not be entitled to any claims against the Organizer (in particular claims for damages and refund of the fee paid).

- **26.** The Exhibitor is liable on a risk basis for its own actions and omissions as well as those of its staff, employees and associates, as well as for any negative consequences of the operation of his equipment.
- **27.** During the shows, all participants are strictly prohibited from consuming alcohol or other psychoactive substances and are prohibited from staying at the show site after consuming alcohol or other psychoactive substances.
- **28.** The organizer may check the sobriety or the presence of psychoactive substances of all show participants, in particular machine operators taking part in the show.
- **28**¹. The Organizer reserves the right to record photos and recordings from the shows and use them in promotional materials, without the need to obtain separate consent from the Exhibitor.
- **28**². In the event of force majeure, unfavourable weather conditions, danger to show participants or other persons, the Organizer has the right to cancel the shows. In the

- event of the shows being cancelled, the Exhibitors who were to take part in them will not be entitled to any claims against the Exhibitor (any entities acting on its behalf), in particular claims for reimbursement of fees or compensation.
- **29.** During the shows, all comments and requests concerning the presentation of machines shall be directed exclusively to the Show Manager.
- **30.** All Exhibition Participants (persons present on its premises) are obliged to maintain an appropriate distance from the place of presentations and presented machines and devices, in particular, during the part of the presentations related to their work, in particular not to cross the designated safety zones (marked by the Organizer in any visible way), to follow all instructions of the Organizer, the Show Manager, and the security services. In the event of a breach of legal regulations, provisions of the Exhibition Regulations, in particular these Regulations, including the provisions contained in the preceding sentence, it is considered that any damage on the part of the Exhibition Participant was caused by his fault, releasing the Organizer (all persons acting on his behalf) from any liability.

PROCEDURES FOR TRANSFERRING PROPERTY FROM EXHIBITOR TO INDIVIDUAL STAND SECURITY

- **1.** Responsibility for the property left behind takes place after visitors and staff have left the Stand, no earlier than at 18:00, on the terms set out in these regulations.
- **2.** A person designated by the Exhibitor prepares a handover report with the participation of Security.
- **3.** The Exhibitor is obliged to follow the recommendations of Security regarding the location of individual elements of the Exhibitor's property within the Stand, as well as any other recommendations aimed at protecting the Exhibitor's property.
- **4.** The handover protocol is signed by a person designated by the Exhibitor and Security. If the Exhibitor fails to comply with the recommendations referred to in point 3, Security may note this fact in the report.
- **5.** After signing the protocol, no person acting on the Exhibitor's instructions or any other third party may stay in the Stand area.

- **6.** The Exhibitor takes over the Stand again by 09:00 after the arrival of the persons indicated by the Exhibitor at the Stand.
- **7.** The takeover takes place after verification of the transfer protocol from the previous day and written confirmation by a person designated by the Exhibitor and Security that there are no objections or a description of any objections.
- **8.** After the takeover of the Stand by the Exhibitor in accordance with point 7 Security leaves the Stand and full responsibility for the property passes to the Exhibitor.
- **9.** If a handover or takeover report is not prepared for reasons attributable to the Exhibitor, no claims are payable against the security employee or the company that has a contract concluded with the Organizer.
- **10.** Security is not responsible for cash or items of significant value (except exhibits), in particular jewellery, works of art, etc. left at the Stand.
